1. APOLOGIES FOR ABSENCE

2. ELECTION OF CHAIRPERSON

Mr Pearson Adams was proposed by Mr Ward and seconded by Mr Snowball as Chairperson for the coming year. Mr Pearson Adams accepted the post and hoped he would live up to expectations!

Mr Ward thanked the outgoing chairman, Mr Machin, for all the work he has done as chairperson over the last six years.

3. MINUTES OF THE LAST PARISH COUNCIL MEETING HELD ON 29 MARCH 2021

The Minutes having been circulated to the councillors prior to the meeting were approved and signed by the Chairman as a true record.

4. MATTERS ARISING FROM THE MINUTES

3.1 Speeding through Brandsby – After much discussion it was decided that the clerk would write to NYCC asking for traffic calming measures to be installed in Brandsby. This issue has been ongoing for at least 16 years.

If this could not be provided advice on whether a device could be purchased by Brandsby Parish Council would be sought and if a grant was available. If this were the case Brandsby residents would be charged with maintaining the device which is quite involved.

Mrs Patmore did point out that the most effective method of slowing the traffic was by having police presence in the village monitoring, and catching offenders, which we do have.

3.2 30mph signs to be relocated- The clerk was asked to contact NYCC to ask whether the 30mph signs could be relocated to beyond Spella bungalow on the Whenby road and also a 30mph sign be erected at the bottom of Olivers bank as

Rectory Corner area is still part of Brandsby. The clerk will point out that many pedestrians use the road and that the footpath is almost none existent etc.

3.3 Bank Mandate – this will be completed at the next meeting.

5. PLANNING APPLICATIONS

PROPOSAL; Works on trees subject to Tree Preservation Order – Limes forming avenue row on North side of Town Street. Reduce height to around 15 mtrs to prevent failure of branches onto road and reduce risk of entire tree failure.
