4. **CHAIRMANS REPORT**

The Report below is in the Chairman's own words :-

"Once again the main business of the Parish Council during the last 12 months has been dealing with various planning applications. It is now certain that Ebor Stores has now closed for ever with the granting of change of use from a shop to a dwelling and we will have to wait to see how the development of the site continues.

As Chairman I would take this opportunity to question our role in planning applications as it would appear that although our opinion is sought the planning system does not appear to take even slightest notice of what we say. There seems to be no logical reason why they should grant permission in an Area of Outstanding Natural Beauty one property in the centre of our village which the a number of local residents and the Parish Council were opposed to and reject a barn conversion for which there were no objections.

Perhaps we should invite a member of the planning department to one of our meetings to explain our role in the future

Playground

There has been no further development with the playground project and I believe the Parish Council will need to review its support during the next 12 months.

Roads & Footpaths

Some progress has been made which included the improvement to the road past Cherry Hill Nursery.

Outstanding matters still include:

- Speeding through the village
- Water erosion at the Village Hall gateway
- The poor state of the footpaths between the village and Rectory Corner
- The re sitting of the Brandsby village sign by the Church

Brandsby Web Site

The village web site is now up and running and all Parish Council meeting dates are published along with Agendas and Minutes of Meetings. Unfortunately it does not appear to have had any effect on the numbers of residents attending meetings.

Hedge Cutting

This was carried out during 2007 though not very efficiently. The Parish Council has issued invoices for the cutting in 2007 though no invoice has been received. A new contractor has been appointed Tony Snowdon from Sutton on Forest and will shortly start on cutting the verges

Once again I would like to thank Christine Cookman for all her help and advice during the year and also to Caroline Patmore.

I would also like to thank our Clerk Susan Ward for all her hard work and keeping me up to date with everything I should be doing”.
